Please read and follow all recommended maintenance, installation, operation and safety instructions provided in this manual. The nameplate is located on the side of the motor housing.

### AMBIENT CONDITIONS

Units should be operated in a well ventilated area where the surrounding air is relatively clean, dry, and temperatures are consistently within the range of 35° F to 95° F. NOTE: UNIT REQUIRES NO LUBRICATION, BEARINGS ARE FACTORY SEALED FOR LIFE.

### ELECTRICAL

SINGLE PHASE MOTORS include internal thermal overload protection, an automatic reset device. **Warning - Disconnect electric power before servicing. Thermal protector can automatically start motor when the device resets.**

THREE PHASE MOTORS do not include internal motor overload protection. It is recommended that a magnetic motor starter with overload devices (heaters) be installed for protection from overload conditions. Heaters should be sized to protect motor from exceeding the rated service factor amperage (SFA) indicated on the motor data plate. Connecting field wiring to motor leads must be made carefully to provide correct rotation, as indicated by the rotation label on the unit. Incorrect rotation will lead to compressor and motor damage.

Both single and three phase motors are designed to operate within a  $\pm 10\%$  range from rated nameplate voltage. Excessively high or low voltage will cause an increase in running amps and motor temperatures which will trip the protective devices in the motor circuit. NOTE: MOST MOTORS ARE DUAL VOLTAGE. Always check wiring label located on rear surface of terminal box cover plate to insure that motor leads are properly connected to match field power supply voltage.

DIRECT CURRENT (DC) MOTORS must be wired in accordance with local electrical codes, protected by a separate over-current protector (fuse) located in the positive (+) lead wire (minimum 8 gauge) from power source. Fuse should be based on 115% of full motor load. Electrical connections must be made using ring type connectors. All connections must be electrically, mechanically and galvanically sound to withstand vibration and movement encountered in normal service of unit. **WARNING: AS WITH ANY ELECTRICAL DEVICE THAT USES A BATTERY FOR A POWER SOURCE, AN ELECTRICAL SPARK MAY OCCUR WHEN CONNECTING MOTOR/COMPRESSOR. DO NOT DISCONNECT MOTOR/COMPRESSOR OR BATTERY WHILE IN THE PRESENCE OF ANY FLAMMABLE LIQUID OR ATMOSPHERE.**

EXTENSION CORDS incur a voltage drop associated with the length of cord and wire size used. For extensions less than 50' in length, use at least number 14 AWG wire size. For extensions 50' and over, a minimum of 12 AWG wire size should be used.

**WARNING— These Products are suitable for pumping only atmospheric air. As defined in Compressed Gas Association Pamphlet G-7, Page 3, atmospheric air is a mixture of elements and compounds where nitrogen and oxygen comprise more than 99% with all other trace gases comprising less than 1%. DO NOT USE THIS PRODUCT IN CONTAMINATED ENVIRONMENTS OR FOR PUMPING MIXTURES OTHER THAN ATMOSPHERIC AIR.**

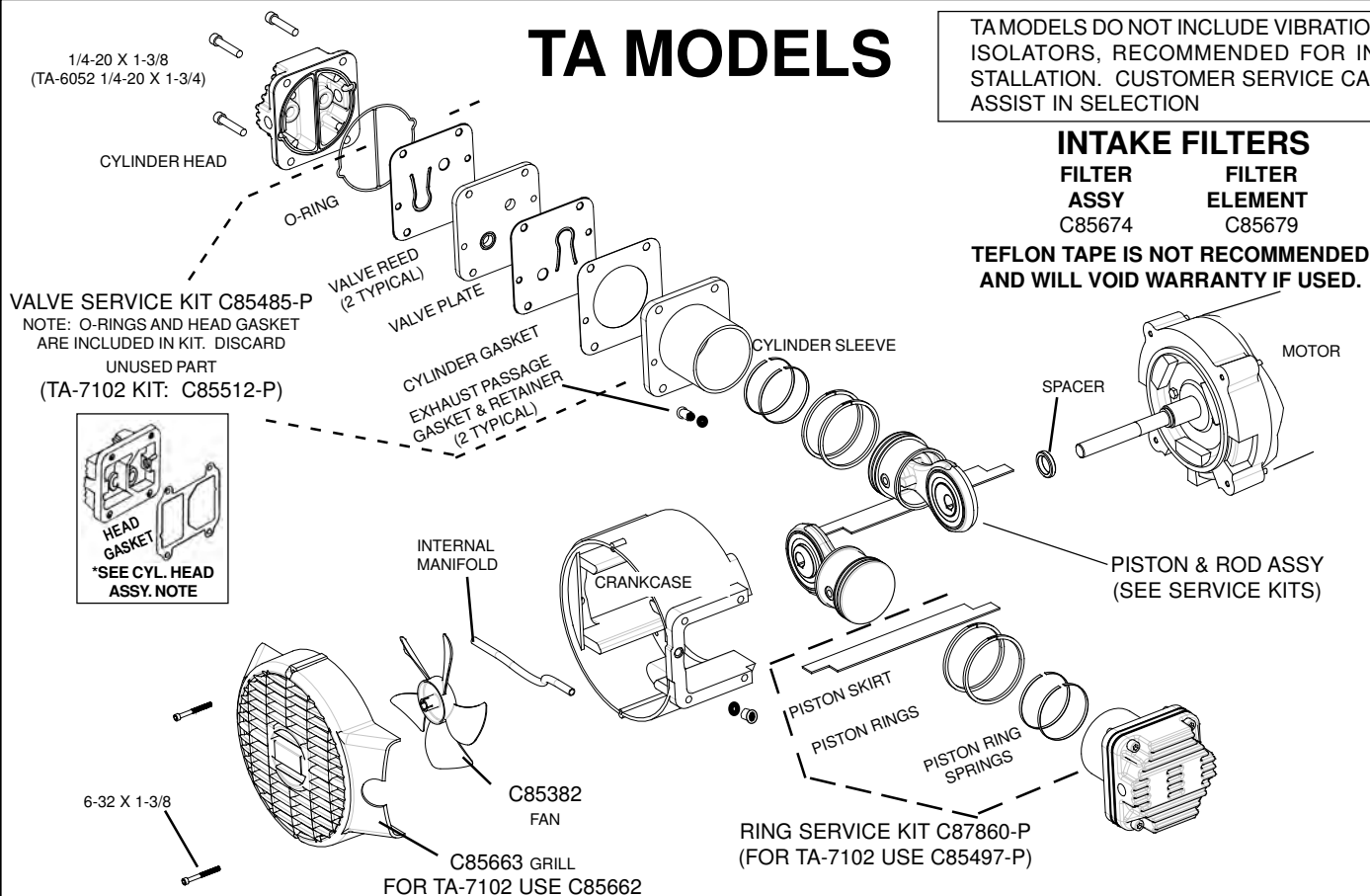

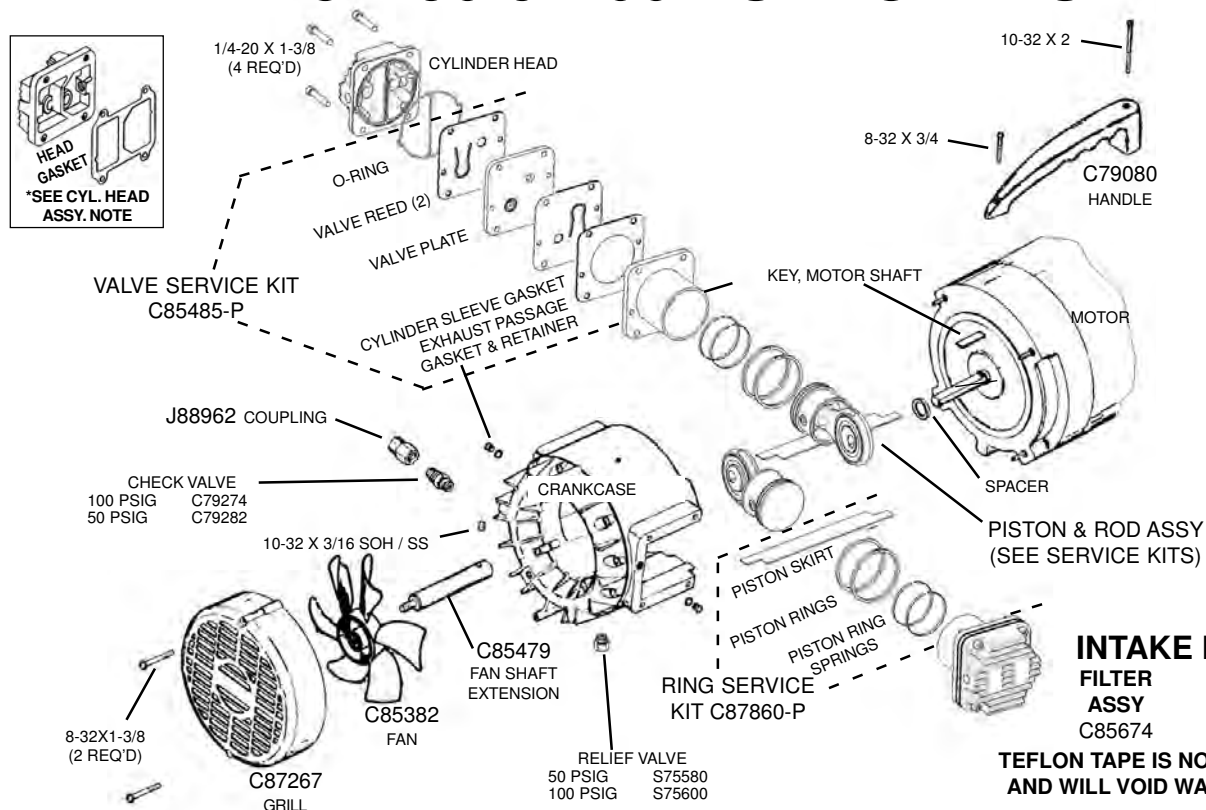

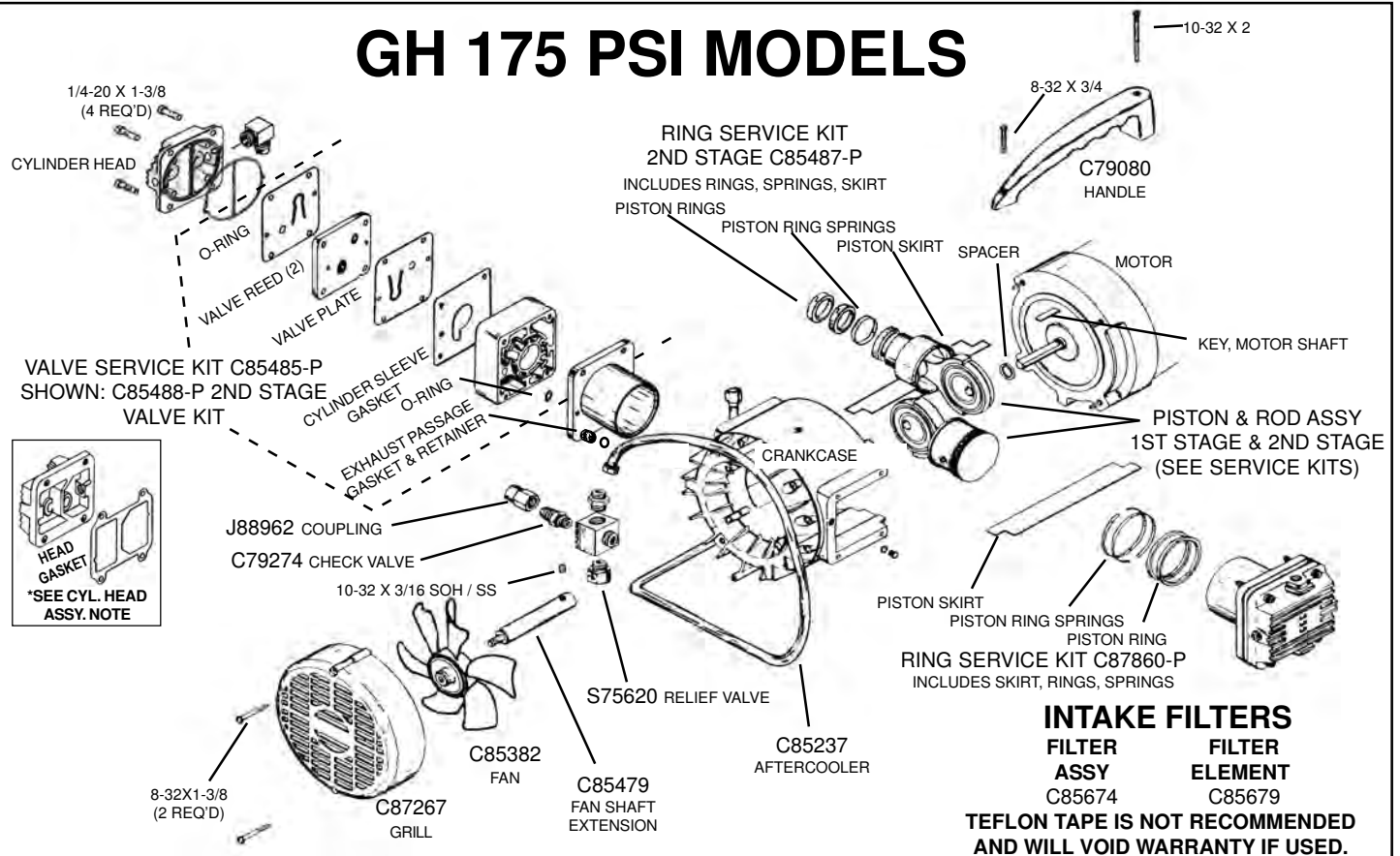

## GH 50 & 100 PSI MODELS

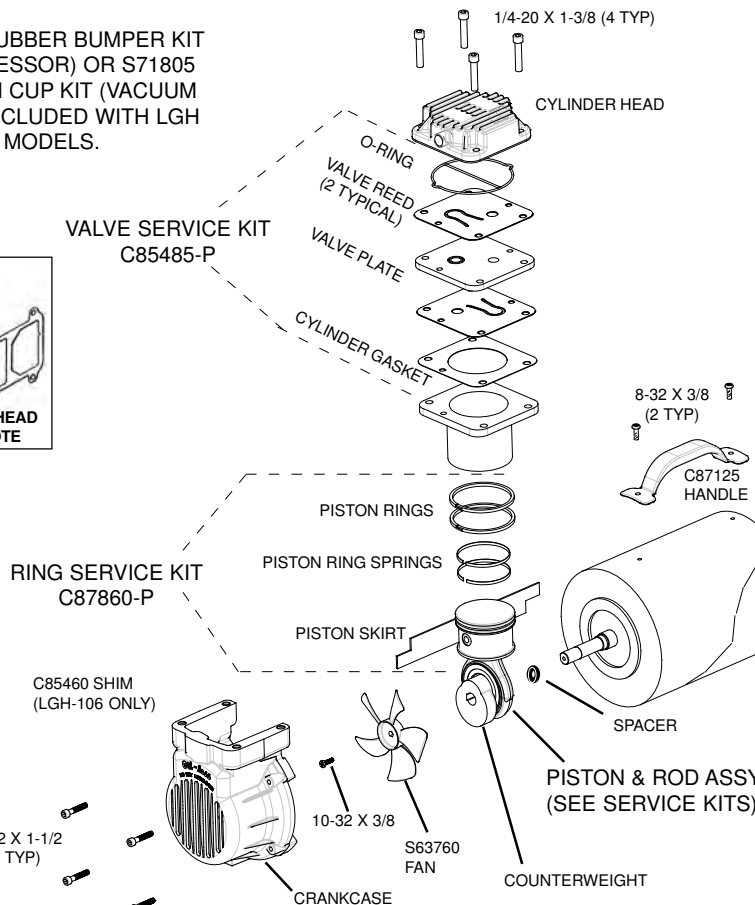

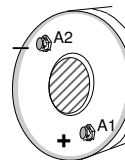

No products will be accepted for return WITHOUT OUR WRITTEN APPROVAL AND UNLESS ACCOMPANIED BY A PROPERLY AUTHORIZED "Service Repair Order" (SRO) initiated by Gardner Denver Thomas, Inc.-Monroe. Return freight must be PREPAID. For non-special or non-custom products accepted for return, transportation (if not prepaid) and a minimum restocking charge of 15% of the invoice value will be charged.
